## STATEMENT OF FAITH

Each member school or college retains its individual distinctives and operating independence. Participation in any or all of the services of ACSI is voluntary. ACSI is a full-service association designed to be a meaningful aid to the school's educational ministry. We subscribe completely to the ACSI Statement of Faith:

- the Bible to be the inspired, only infallible, authoritative, inerrant Word of God. (*II Timothy 3:15, II Peter 1:21*)
- there is one God, eternally existent in three persons—Father, Son, and Holy Spirit. (*Genesis 1:1, Matthew 28:19, John 10:30*)
- in the deity of Christ, (*John 10:33*); His virgin birth, (*Isaiah 7:14, Matthew 1:23, Luke 1:3*); His sinless life, (*Hebrews 4:15, Hebrews 7:26*); His miracles, (*John 2:11*); His vicarious and atoning death, (*I Corinthians 15:3, Ephesians 1:7, Hebrews 2:9*); His resurrection (*John 11:25, I Corinthians 15:4*); His ascension to the right hand of the Father, (*Mark 16:19*); and His personal return in power and glory. (*Acts 1:11, Revelation 19:11*)
- in the absolute necessity of regeneration by the Holy Spirit for salvation, because of the exceeding sinfulness of human nature; and men are justified on the single ground of faith in the shed blood of Christ; and only by God's grace and through faith are we saved. (*John 3:16-21, John 5:24, Romans 3:23, 5:8-9, Ephesians 2:8-10, Titus 3:5*)
- in the resurrection of both the saved and the lost; they that are saved unto the resurrection of life and they that are lost unto the resurrection of damnation. (*John 5:28-29*)
- in the spiritual unity of believers in our Lord Jesus Christ. (*Romans 8:9, I Corinthians 12:12-13, Galatians 3:26-28*)
- in the present ministry of the Holy Spirit by whose indwelling the Christian is enabled to live a Godly life. (*Romans 8:13-14, I Corinthians 3:16, 6:19-20, Ephesians 4:30, 5:18*)

- that the Lord's Supper is an ordinance whereby believers show forth the Lord's death until He comes again. (*I Corinthians 11:23-26*)

## APPLICANT'S CERTIFICATION AND AGREEMENT

In addition, I hereby release the school, my former employers, references, and all other parties from any and all claims, demands, or liabilities arising out of or in any way related to such investigation or disclosure. I waive the right to ever personally view any references given to the school.

Since I will be working with children, I understand that I must submit to a fingerprint check by the FBI and possibly other federal and state authorities. I agree to fully cooperate in providing and recording as many sets of my fingerprints as are necessary for such an investigation. I authorize the school to conduct a criminal records check. I understand and agree that any offer of employment that I may receive from the school is conditioned upon the receipt of background information, including criminal background information. The school may refuse employment or terminate conditional employment if the school deems any background information unfavorable or that it could reflect adversely on the school or on me as a Christian role model.
