Each member school or college retains its individual distinctives and operating independence. Participation in any or all of the services of ACSI is voluntary. ACSI is a full-service association designed to be a meaningful aid to the school's educational ministry. We subscribe completely to the ACSI Statement of Faith:

- the Bible to be the inspired, only infallible, authoritative, inerrant Word of God. (II Timothy 3:15, II Peter 1:21)

- in the absolute necessity of regeneration by the Holy Spirit for salvation, because of the exceeding sinfulness of human nature; and men are justified on the single ground of faith in the shed blood of Christ; and only by God's grace and through faith are we saved. APPLICANT'S CERTIFICATION AND AGREEMENT

Since I will be working with children, I understand that I must submit to a fingerprint check by the FBI and possibly other federal and state authorities. I understand and agree that any offer of employment that I may receive from the school is conditioned upon the receipt of background information, including criminal background information. The school may refuse employment or terminate conditional employment if the school deems any background information unfavorable or that it could reflect adversely on the school or on me as a Christian role model.
