

Palmetto Fellows Scholarship:

1. SAT at or above 1200 or ACT at or above 25
2. 3.5 cumulative GPA at the end of junior or senior year
3. Rank in the top six percent of the class at the end of sophomore, junior or senior year.
4. Any student who scores 1400 or above on the SAT or 31 on the ACT and has a 4.0 cumulative GPA will be eligible, without regard to class rank.

Scholarships are \$6,700 annually. Applications submitted to the CHE.

Life Scholarship:

Four-Year College-

You must meet two of the three criteria:

1. 3.0 GPA at graduation
2. Top 30% of graduating class
3. 1100 SAT / 22 ACT

Scholarships are \$5000 annually at 4-year college.

Two-Year College-

Must graduate from high school with a 3.0 GPA

Scholarships are cost of tuition plus \$300 book allowance.

No applications. College will notify those who qualify.

Life & Palmetto Fellows Enhancements:

Recipients attending eligible four-year institutions in S.C. may qualify for up to \$2500 in additional funds beginning their sophomore year. Requirements- must declare an approved major in science or math and earn at least 14 credit hours of instruction in approved math or life and physical sciences or a combination of both by the end of the first year of college enrollment.

Hope Scholarship:

Four year colleges only

Must earn a 3.0 GPA at graduation

One year scholarship for first-time entering freshmen only

Scholarships are up to \$2800 (including a \$300 book allowance.)

No applications. College will notify those who qualify.

SC Tuition Grants

Need-based grant program for SC residents attending full-time one of 20 eligible in-state private colleges.

Freshmen – Top 75% or 900 SAT/19 ACT or 2.0 final GPA

Application is FAFSA – June 30 deadline

Average freshman awards for 2022 were \$4500.

Lottery Tuition Assistance (LTAP)

Two year institutions only

Must complete the FAFSA

Currently \$85 per credit hour up to 15 hours max

Award amounts may vary depending on the legislature.

SC Need Based Grant

FAFSA required

Up to \$2500 annually for full time students enrolled at a SC public college or university.

Up to \$1250 annually for part time students enrolled at a SC public college or university.

Federal Pell Grant

Based on financial need (FAFSA); cost of attendance at your college; status as full time/part time student

For 2022-23 school year, \$6895 maximum award

Federal TEACH Grant

\$4000 annual/\$16,000 aggregate limit

Must teach 4 of the first 8 years in a low income school and a high need field.

Converts to an unsubsidized loan if the teacher does not fulfill teaching requirements.

SC Teaching Fellows

Scholarship designed to recruit high school seniors into teaching.

Annual award up to \$6000. (\$24,000 over 4 years)

A fellow agrees to teach in SC for one year for each award given.
